Q: How do you know that a room on the internet is a decent and safe room?

- On the internet all rooms are ‘nice, bright, beautiful and cosy’
- How do you know the house is safe
 - Smoke detectors and fire extinguishers (*annual maintenance check*)
 - Heating and hot water (*24/7 service contract and annual maintenance check*)
 - Fire resisting materials (walls, doors, carpet etc.)
- Is an owner reliable?
 - Reasonable rental price
 - Failures and malfunctions will be fixed
 - Deposit will be returned in time
- Scams on the internet
 - Especially foreign students are target

Q: How long does it take to set a room completely on fire?



Timeline flashover (room)

00:40 *flames ignite the arm of sofa*

00:56 *flames impinge on wicker chair*

01:23 *smoke is beginning to appear*

01:45 *flames approaching ceiling*


01:55 *smoke triggers the smoke alarm in the hallway*

02:05 *flames spread over the ceiling and walls*

02:30 *flashover of the room*

A: In less than 3 min a fire has spread over the room (flashover)

- 30 years ago this would take 17 minutes
 - Main reason is the flammability of the materials nowadays
 - Simple measures like closing doors (rooms, kitchen etc.) will double the time to escape

"What if a fire were to break out in a house where two hundred people have gathered," says Pascal Breuls, director of Student Services. The police regularly receive reports about illegal house parties, in particular at the end of block periods. Maastricht University makes students aware of the risks.

House parties have been popular among foreign students for years. "They are not used to getting together in a pup or club, it's a cultural thing," says Maurice Evers, project manager of Student&Stad. "They organise a party at home to celebrate the end of a block and invite people through closed Facebook groups or other

student, but it becomes unsafe when too many people get together. Generally there are at least fifty visitors; often even more than a hundred." Fire or panic may have disastrous consequences. In the town of Ede, the floor in a student house collapsed during a party two years ago. The wooden floor couldn't hold the weight of twenty people dancing and jumping. Four people were injured. Evers points out that the organiser may be facing criminal prosecution if a visitor is seriously hurt or even dies.

"If something like that were to happen in Maastricht, all eyes would look to the UM and the press would be on my doorstep," says Breuls. "But we can't do anything, we aren't law enforcers."






Regulations and layout

- Max tenants per toilet, bathroom, kitchen




Regulations for the neighborhood

- Awareness of tenants through information




Fire safety from 2 or more units

- Entire building a fire compartment
- Linked smoke detectors and fire extinguishers
- Annual maintenance check of smoke detectors etc.
- Kitchen door 30 min fire resistant
- CO alarm near gas heaters
- All electrical wiring needs to be covered




Regulations for rent / lease

- Reasonable rental prices
- Returning deposits within a reasonable time
- Decent rent administration
- Liability insurance owner (WAB)
- Safe behavior



Burglary security


- Burglary strips on all exterior doors

Regulations for control/management

- Service contract (annual) for heating and hot water
- Annual maintenance control of fire safety





Keurmerk control application

- Keurmerk inspection by a qualified inspector
 - Inspector will inspect the house and all documents
 - If everything is OK, the house will get a keurmerk
 - Random recheck of the house (1x every 5 years)
- Annual keurmerk inspection by the landlord
 - Checks the building with the control application
 - Needs to make pictures of all requirements
 - Inspector will check the annual report
- Inspection report of the room with tenant
 - Report of the state of the room (with pictures)
 - Can be signed digitally by owner and tenant
 - Discussions about the deposit



Keurmerk website

- Website
 - Information for landlords, tenants and neighbours
 - Interactive map of the 'keurmerk' properties
 - Tenants / neighbours can contact the landlord (or caretaker)
 - Complaint form on the website
- Model documentation
 - Standard rental contracts (Dutch/English)
 - House rules (Dutch/English)

Geschillencommissie *(complaint committee)*

- Composition of the committee
 - Independent chairman (retired judge)
 - Member from the tenants / university
 - Member from the landlords (housing corporations / private)
 - Secretary of the keurmerk foundation



Benefits for all stakeholders

- University: *higher quality of housing offer (attractiveness / competitiveness)*
- Municipality: *higher level of awareness, safety and quality of life*
- Tenants: *prior assurance of a secure and reliable house*
- Parents: *can send their kids to Maastricht with a reassured feeling (about safety)*
- Neighbours: *can get easier in contact with the owner*
- Landlord: *proof of a safe building and can differentiate positive in the rental market*
